# WWALS Working Hard for Your Watershed

**Opposition to the pipeline** WWALS has jumped another hurdle. Thanks to the hard work of WWALS members, John and Gretchen Quarterman, Chris and Deanna Mericle, and Tom Edwards, we have succeeded in being granted an administrative hearing regarding our opposition to Florida DEP's intent to issue an environmental resource permit to Sabal Trail Transmissions to construct their natural gas pipeline through many counties in Florida, including Hamilton and Suwannee in WWALS's watershed: October 19-22 in Jasper (or Live Oak). WWALS now needs significant funds for the legal costs including attorney's fees and expert witness fees. We have received many new memberships showing support of our efforts because many people are opposed to having their property, rivers, and water supply degraded by a pipeline that is not needed and of no benefit to those if affects. **Solar energy** Members Chris and Deanna Mericle attended the Florida Congressional Delegation meeting in Jasper on Sept. 3rd held with State Representative Elizabeth Porter and State Senator Bill Montford. Chris requested that they support "a real solar initiative" that will "allow for financing and not restrict solar producers from selling their product." He stated that natural gas is not a necessary "bridge fuel" from coal and oil as has been suggested. Let's just go straight to solar. Senator Montford agreed that moving toward solar power will become necessary, but the primary obstacle is that the cost to convert is too high at this time. In fact, however, the cost of solar energy continues to come down. When pipeline and power companies are willing to spend \$3 billion on a pipeline, it makes solar energy seem a lot more cost efficient, not mention cleaner.

**Wastewater spill** At the same above-mentioned Congressional Delegation meeting, Hamilton County officials expressed their dismay at yet another spill of wastewater into the Withlacoochee River by the city of Valdosta in late August. WWALS immediately asked Valdosta and received an explanation of the spill and the updated timeline for the completion of the new Valdosta

### Community Outreach and Education


