

### I. INVOCATION

Vice-Chair Maurice Perkins noting a quorum being present called the meeting to order at 7:00 p.m. Commissioner Kevin Parnell gave the invocation.

### II. PLEDGE OF ALLEGIANCE

The Council and guests pledged allegiance to the flag of the United States of America.

### III. INTRODUCTIONS

Vice-Chair Perkins welcomed John Jenkins, County Manager, Dixie County; Paul Martin, Citizen, Dixie County; and Stew Lilker, Columbia County Observer. Also, in attendance at the meeting virtually was Diana Davis, Executive Director, Alachua County League of Cities and wife of Council Member Louie Davis.

### VIII. COMMITTEE REPORTS

- A. Executive Committee
  - 1. Proclamation Declaring October 2025 as Community Planning Month

Mr. Koons stated that the month of October 2025 has been designated to celebrate National Community Planning Month. He noted the American Planning Association and its professional institute, the American Institute of Certified Planners, endorse National Community Planning Month as an opportunity to highlight the contributions sound planning and plan implementation make to the quality of life in communities and the environment. Mr. Koons also stated that the Executive Committee recommends that the Council join in the celebration of National Community Planning Month by proclaiming October 2025 as Community Planning Month in north central Florida.

ACTION: Commissioner Ingle made the motion, with a second by Vice-Mayor Bouie Hutchinson, to adopt a proclamation proclaiming October 2025 as Community Planning Month in the north central Florida region, which has been attached hereto and made a part of these minutes. The motion carried unanimously.

2. Proclamation Declaring October 3, 2025 as Manufacturing Day

Mr. Koons stated that October 3, 2025 has been designated Manufacturing Day. He added that Manufacturing Day is an effective way to highlight the importance of manufacturing in the north central Florida region and support those manufacturing and school programs that prepare our workforce. Mr. Koons also stated that the Executive Committee recommends that the Council proclaim October 3, 2025 as Manufacturing Day in north central Florida.

ACTION: Commissioner Cornell made the motion, with a second by Commissioner Demps, to adopt a proclamation proclaiming October 3, 2025 as Manufacturing Day in the north central Florida region, which has been attached hereto and made a part of these minutes. The motion carried unanimously.

3. Proclamation Declaring October 20-26, 2025 as Florida City Government Week

Mr. Koons stated that the Florida League of Cities has designated the week of October 20-26, 2025 as Florida City Government Week. He stated that Florida City Government Week is part of an ongoing effort sponsored by the League to raise public awareness about services that cities perform and to educate the public about how city government works. Mr. Koons also stated that the Executive Committee recommends that the Council join in the recognition of city government by proclaiming the week of October 20-26, 2025 as Florida City Government Week in north central Florida.

**ACTION:** 

Commissioner Townsend made the motion, with a second by Mayor Hope, to adopt a proclamation proclaiming October 20-26, 2025 as Florida City Government Week in the north central Florida region, which has been attached hereto and made a part of these minutes. The motion carried unanimously.

4. Executive Director Annual Performance Evaluation

Vice-Chair Perkins stated that the employment contract between the Executive Director and the Council specifies that the Executive Committee shall adopt performance standards to annually review and evaluate the Executive Director. He noted the contract further specifies that the annual review and evaluation of the Executive Director shall be conducted by the Executive Committee. Vice-Chair Perkins stated the contract also specifies that at its discretion, the Executive Committee is authorized to provide a merit increase to the Executive Director on an annual basis commencing October 1st of each year.

Vice-Chair Perkins stated that the Executive Committee has adopted performance standards to review and evaluate the Executive Director and that each Committee member performed their review prior to the September 25, 2025 Executive Committee meeting. He reported that the review resulted in "above average performance" or "exceeds job requirements" for all evaluation standards, with an overall average score of 4.9 on a 5.0 scale. Vice-Chair Perkins stated that, based upon this review, the Executive Committee awarded the Executive Director a five percent merit pay adjustment. He reported that Mr. Koons requested that his merit pay increase for Fiscal Year 2025 and Fiscal Year 2026 be deferred until Fiscal Year 2027. Vice-Chair Perkins further reported that the Executive Committee approved Mr. Koons' request concerning his merit pay increase deferments.

No Council action was required on this item.

B. Clearinghouse Committee - Committee Level Comprehensive Plan Review Items

Commissioner Melissa McNeal, Chair of the Clearinghouse Committee, reported that the Clearinghouse Committee met in person and virtually via communications media technology earlier in the evening and reviewed the following local government comprehensive plan amendments which were included on the Council agenda for consideration.

Commissioner McNeal stated with regards to these items, the Committee found that the local government comprehensive plans, as amended, were not anticipated to result in significant adverse impacts to regional facilities, Natural Resources of Regional Significance or adjacent local governments. She stated that the Committee recommends forwarding these findings to the respective local government and the Florida Department of Commerce.

### IX. EX-OFFICIO MEMBER REPORTS

Kathryn Craver, Outreach/Communications Director, Florida Department of Environmental Protection, Northeast District, reported that the Department is considering reestablishing the posting of water quality sampling results as part of its Watershed Information Network page on its website.

David Tyler, Rural Transportation Planning Manager, Florida Department of Transportation District 2, reported that the Department will be conducting a Tentative Work Program for Fiscal Year 2026-27 to Fiscal Year 2030-31 public hearing on October 21, 2025 at 4:30 p.m. at the District 2 Urban Area Office in Jacksonville.

Austin Burgess, Senior Biologist, Florida Fish and Wildlife Conservation Commission, stated that the Commission offers wildlife conservation planning services to landowners and local governments throughout the region.

Tyler Winburn, Legislative and Government Affairs Coordinator, reported that the District will be posting links on its website Water Data Portal page to the Florida Department of Environmental Protection water quality sampling results and the City of Valdosta, Georgia water quality sampling results beginning September 26, 2025.

### XI. EXECUTIVE DIRECTOR REPORT

### A. Florida Regional Councils Association Monthly Activity Report

Mr. Koons reported that the Florida Regional Councils Association is the statewide organization of the ten regional planning councils. He stated that the Association strengthens Florida's regional planning councils, partners with government and the business community to enhance regional economic prosperity and improves the consistency and quality of regional planning councils programs to ensure they add value to state, regional and local initiatives. Mr. Koons also stated that the Association strives to accomplish these goals by carrying out the activities listed in the August 2025 activity report included in the Council meeting packet. He reviewed the activities listed in the August 2025 report.

### B. Florida Regional Councils Association Policy Board Report

Mr. Koons reported that Commissioner Chestnut, Commissioner Demps, Vice-Mayor Mortimer and he attended the semi-annual meeting of the Florida Regional Councils Association Policy Board held in Tampa on August 22, 2025. He stated the Policy Board heard a presentation from Jason Lauritsen, Chief Conservation Officer, Florida Wildlife Corridor Foundation. Mr. Koons noted the Policy Board accepted Financial Statements for Fiscal Year 2023-24 and received a financial report. Finally, he reported the Policy Board also adopted a budget for Fiscal Year 2025-26, received a legislative report and elected officers for the 2025-26 Policy Board Executive Committee.

### C. Florida Chamber Foundation Scorecard<sup>TM</sup>

Mr. Koons reported that the Florida Chamber Foundation has developed the Florida Scorecard<sup>TM</sup> to provide Florida leaders the metrics needed to secure Florida's future. He stated that the Florida Chamber Foundation's objective to developing a 20-year, statewide strategic plan requires a commitment to measuring our current status and progress toward the stated goals of the Six Pillars 20-year Strategic Plan. Mr. Koons noted that the Scorecard reports metrics for each of the following Six Pillars: Talent and Supply Education, Innovation and Economic Development, Infrastructure and Growth Leadership, Business Climate and Competitiveness, Civic and Governance Systems, and Quality of Life and Quality Places. He reviewed the September 2025 Scorecard<sup>TM</sup> that was included in the Council meeting packet.

### D. Legislative Report

Mr. Koons stated the 2026 Legislature Session will convene on January 13, 2026 and is scheduled to adjourn on March 13, 2026. Mr. Koons reported that the legislative interim Committee schedule is, as follows:

Suwannee River Economic Council, Inc.'s Memorandums of Agreement will expire June 30, 2026. Therefore, the Council must use a competitive request for proposal process to recommend the Community Transportation Coordinators for Dixie, Gilchrist and Union Counties.

The Council will accept proposals from qualified agencies or firms for the award of a contract to coordinate transportation services for the transportation disadvantaged in Dixie, Gilchrist and Union Counties. The selected contractors will be the designated community transportation coordinator under Florida's Transportation Disadvantaged Program, as authorized by Chapter 427, Florida Statutes, and more fully described in Rule 41-2, Florida Administrative Code.

A Technical Review Committee will be appointed by the Executive Director. The Technical Review Committee will be comprised of Council employees. Each Technical Review Committee member will assign points to the proposals. A numerical rank order will be established by the Technical Review Committee for all proposals received by the Council.

The proposals and rankings by the Technical Review Committee will be provided to the Dixie, Gilchrist and Union County Transportation Disadvantaged Coordinating Boards for review. The Boards may provide non-binding comments concerning the proposals to the Council.

The Council will review the recommendations of the Technical Review Committee and any comments provided by the Dixie, Gilchrist and Union County Transportation Disadvantaged Coordinating Boards and forward recommendations to the Florida Commission for the Transportation Disadvantaged concerning the designation of the community transportation coordinators including any terms of designation. The Florida Commission for the Transportation Disadvantaged will make the final designations.

#### **RECOMMENDATION:**

#### **BACKGROUND:**

The Council takes action during each year to accept work under contracts and additional grants which were not anticipated when the original budget was prepared. In addition, because the Council adopts the budget 16 months prior to fiscal year end, generally a number of conditions change which cause the expenditure levels to vary from the original figures.

To amend the budget, by taking into account both the contractual changes made during the year and variations in expenditure levels, the Council annually considers a fiscal year-end amendment. Consistent with that practice, staff will propose budget changes for the current year budget. This will include both increases and decreases in revenue for various program areas with associated changes in Direct and Indirect expenses.

The Finance Committee recommends that the Council authorize the Finance Committee to review and approve on behalf of the Council the Fiscal Year 2024-25 amended budget within 60 days following the end of the fiscal year.

#### RECOMMENDATION

Adopt Resolution No. 2025-19 concerning the annual review of the North Central Florida Comprehensive Economic Development Strategy 2023-2027 as recommended by the Comprehensive Economic Development Strategy Committee.

#### **BACKGROUND**

The Council has been designated by the U. S. Economic Development Administration as an Economic Development District since 1978. As such, the Council is responsible for developing and adopting a Comprehensive Economic Development Strategy. The purpose of the strategy is to analyze the regional economy and serve as a guide for establishing regional goals and objectives, developing and implementing a regional plan of action, and identifying investment priorities and funding sources.

The Comprehensive Economic Development Strategy is designed to bring together the public and private sectors in the creation of an economic roadmap to diversify and strengthen regional economies by attracting private investment that creates jobs. The strategy must be the result of a continuing economic development planning process developed by a Comprehensive Economic Development Strategy Committee representing both the public and private sector, and must set forth the goals and objectives necessary to solve the economic development problems of the region.

The Comprehensive Economic Development Strategy Committee appointed by the Council includes representatives of the private sector, public officials and workforce development boards. The Committee is responsible for the development of the strategy and recommendation of the strategy to the Council for adoption.

Based upon the recommendation of the Comprehensive Economic Development Strategy Committee, the Council adopted the Comprehensive Economic Development Strategy in September 2022. The Comprehensive Economic Development Strategy Committee met virtually on October 16, 2025 to review activities conducted during the past year to support the goals and objectives of the Comprehensive Economic Development Strategy. Regional Joint Mitigation Resiliency Project

The Florida Commerce has awarded a \$1.499 million Rebuild Florida Community Development Block Grant General Planning Support Program grant to the East Central Florida Regional Planning Council to complete a Regional Joint Mitigation Resiliency Project.

The East Central Florida Regional Planning Council has entered into interagency agreements with the regional planning councils that have counties that were declared federal disaster areas as a result of Hurricane Irma to assist in completing the project. These regional planning councils include Central Florida Regional Planning Council, Northeast Florida Regional Council, North Central Florida Regional Planning Council, Tampa Bay Regional Planning Council and the Treasure Coast Regional Planning Council.

The regional planning councils are engaging in cross collaboration to provide a seamless network of community partners setting forth a single consistent methodology for vulnerability, risk analysis and assessments with reduced focus on county boundaries in order to identify potential multi-jurisdictional or multi-county solutions. The project will fill an identified gap in resilience efforts by focusing on the impacts of flooding hazards to the inland counties in Florida.

The scope of work includes the following activities.

- Future Extreme Rainfall Modeling;
- Mitigation Needs Assessment, Template and Mitigation Priority Areas and Project List;
- Small Area Mitigation Plans;
- Regional Resilience Exposure Tool;
- Interactive Best Practice Application; and
- Stakeholder Engagement.
