#### 2. PROJECT DESCRIPTION

A State Environmental Impact Report (SEIR) was approved in 1998 for the Suncoast Parkway, a four-lane limited access facility on new alignment from US 98 in Hernando County to US 19/98 in Citrus County.

This reevaluation is being conducted to evaluate design changes since the original 1998 PD&E SEIR for Suncoast Parkway Phase 3A (extend Suncoast Parkway from CR 486 to CR 495), FPID 442764-2. The project was discussed in detail in the previous Re-evaluation for FPID 442764-2 approved on October 18, 2023, and the reader should refer to that document for a detailed description of the project. The purpose of this Re-evaluation is to consider minor subsequent design modifications (described in Section 4 below) since the 2023 Re-evaluation was completed.

#### 3. CHANGES IN APPLICABLE LAW OR REGULATION

Are there changes in federal or state laws, rules, regulations, or guidance that require consideration since the date of the original Environmental Document or subsequent Re-evaluation(s)? Yes

Subsequent to the October 18, 2023 Re-evaluation, the Tri-colored bat, now a new federal proposed threatened species, has potential habitat within the project limits. As of August 2024, the bat has not yet been approved for listing but that is expected late Summer 2024. Refer to Section 8, Commitment Status, below.

#### 4. EVALUATION OF MAJOR DESIGN CHANGES AND REVISED DESIGN CRITERIA

Are there major design changes, including but not limited to changes in the alignment(s), typical section(s), drainage/stormwater requirements, design control and criteria, or temporary road or bridge? Yes

Since the most recent SEIR Re-evaluation for FPID 442764-2 completed in October 2023, the construction plans for the Suncoast Parkway 2 (SR 589) Phase 3A have been advanced to 90% design completion. The 90% plans reflect a minor change in roadway and access at CR 495 (North Citrus Avenue) and West Tom Mason Drive. Based on a request from the local residents and Citrus County, the proposed design has been modified to allow full access to/from West Tom Mason Drive, and now provides a left turn lane to West Tom Mason Drive from northbound CR 495. All other features

remain generally unchanged since the October 2023 re-evaluation.

Minor changes in ROW are needed to provide the altered roadway access to CR 495 described in Section 4.

#### Is there a change in anticipated relocation(s)? No

The changes to the project since the last Re-evaluation in October 2023 do not require any relocations.

#### b. CULTURAL

# Are there changes in impacts to cultural resources pursuant to Chapter 267, F.S. (historic sites/districts and archaeological sites)? Yes

A December 2023 CRAS Addendum for FPID 442764-2 was prepared to evaluate new pond sites and revisions to previous design in the CR 495 area. The project area of potential effect (APE) was determined by evaluating the improvements that will be implemented as part of the proposed project. The archaeological APE consists of the footprint of the proposed pond sites that have not been previously surveyed and the previously unsurveyed segments of proposed roadway ROW. The historic resources APE consists of a 150-foot buffer surrounding the unsurveyed ponds and ROW.

The CRAS addendum documented two previously-identified archaeological resources that were previously determined ineligible for the National Register of Historic Places (NRHP). No new archaeological resources were found. Three newly identified historic resources were identified, none of which were recommended for listing in the NRHP either individually or as a historic district.

The CRAS addendum determined that the project will have no adverse effect on archaeological or historic properties. The SHPO concurred with this finding on February 8, 2024.

A noise analysis was performed for the previous October 2023 Re-evaluation for FPID 442764-2. The minor access changes covered in this current Re-evaluation do not require any kind of re-assessment of noise impacts.

#### What is the status of Contamination?

An April 2024 CSER Update memo (attached) was prepared to supplement a previous 2023 update prepared for the previous Re-evaluation of FPID 442764-2.

The memo determined that Level II contamination impact to construction assessment by the FTE Environmental Management Office is warranted at proposed drainage alternatives Pond 2-8C and FPC-98 rated medium risk. Regarding Site #1 Citrus Sand & Debris I C&D Landfill rated medium risk, the project design and construction managers shall inform the FTE Environmental Management Office in the event dewatering is anticipated south of CR 486. The FTE Environmental Management Office may then conduct Level II Contamination Impact to Construction Assessment to evaluate whether groundwater treatment may be warranted during construction dewatering and provide results to the design or construction project manager.
