WWALS Working Hard for Your Watershed

U.S. Congressman Ted Yoho FL-03 on May 15th 2016 hiked with about 30 people where Sabal Trail proposes to drill under the Suwannee River at Suwannee River State Park near Live Oak, FL All saw in person many sinkholes along the route Sabal Trail failed to mention to permitting agencies. A staffer from U.S. Senator Bill Nelson's office was also present as well as a county commissioner each from Suwannee and Hamilton counties, and several candidates for the Florida statehouse. The hike was a joint effort of WWALS, Gulf Restoration Network, Environment Florida, Sierra Club,



Our Santa Fe River, SpectraBusters, Earth Ethics, Environment America, and Environment Georgia. The group asked Rep Yoho to send a letter to the the U.S. Army Corps of Engineers (USACE) asking for a USACE site visit to see the discrepancies in Sabal Trail's information and for USACE to open a Supplemental Environmental Impact Statement (SEIS) for public comment. At the end of the event, Rep. Yoho said we had his committment to get answers before the pipeline proceeds to questions about the discrepancies between what is being reported by Sabal Trail and what can be seen first hand. Three days later Rep. Yoho instead issued a press release that appeared to say all issues had already been handled. We await Rep. Yoho doing what he said he would do.

WWALS Ambassador Dave Hetzel and President John S. Quarterman met with Rep. Austin Scott GA-08 after a joint letter from WWALS and Flint Riverkeeper, and Scott indicated he would ask the Corps for a SEIS if other Congress members would. Unfortunately, Scott has since said that's "on hold". We await him taking it off hold and sending the Corps a letter.

Rep. Sanford Bishop GA-02 did write a letter to USACE asking for a SEIS and for that we thank him!
